SENIOR STAFF RECOMMENDATIONS FOR FUNDING OF PROPOSALS SUBMITTED UNDER THE BOARD OF REGENTS SUPPORT FUND COMPETITIVE GRANTS AND ENDOWMENT MATCHING PROGRAMS, FY 2015-16

SECTION A: INTRODUCTION

A.1 Constitutionally Prescribed Program Components

The Constitution specifies that the Board of Regents Support Fund may be used to support any or all of the following:

- a. The carefully defined research efforts at public and private universities in Louisiana;
- b. The endowment of chairs for eminent scholars;
- c. The enhancement of the quality of academic, research or agricultural departments or units within a university; and
- d. The recruitment of superior graduate students.

A.2 FY 2015-16 Board of Regents Support Fund Plan and Budget

a. Projected Budget and Funds Available

On September 25, 2014, the Board of Regents adopted the FY 2015-16 Plan and Budget for the Board of Regents Support Fund, which was later approved by the Governor and the Legislature. Based on Revenue Estimating Conference (REC) projections, the Plan and Budget allocated \$26,500,000 across Support Fund components as follows:

b. Actual Funds Available

Since approval of the FY 2015-16 BoRSF Plan and Budget in September 2014, the REC has issued several opinions relative to the amount of money projected to be available for higher education's portion of the Support Fund. The most recent estimate, released in February 2016, was \$24,850,000. This projection is significantly lower than the previous REC guidance and projections used to derive the approved Plan and Budget. In addition, during the 2016 Special Legislative Session action was taken to cut the Support Fund by \$1,318,250, in accordance with statutory authority, to help offset State budget deficits. This lowers the total available for obligation in FY 2015-16 to \$23,531,750. As a result, substantial reductions in anticipated first-year funds must be taken in the competitive non-endowment Enhancement and Research and Development (R&D) program components.

SECTION B: ENDOWED CHAIRS FOR EMINENT SCHOLARS COMPONENT

B.1 Competitive Endowed Chairs

Eight (8) proposals were submitted and deemed eligible for funding consideration this year under the Competitive subprogram. Six (6) proposals requested \$400,000 each from the Support Fund to endow \$1 million chairs; one (1) proposal requested \$800,000 to endow a \$2 million chair; and one (1) proposal requested \$1,200,000 to endow a \$3 million chair. All requests were to establish new chairs.

B.2 Restricted Bequest Endowed Chairs

No requests for matching of restricted bequests were submitted in FY 2015-16.

B.3 Summary of the Endowed Chairs for Eminent Scholars Program

The eight (8) Endowed Chairs proposals requested a total of \$4,400,000 in matching funds from the Support Fund. All disciplines were eligible to apply. A team of out-of-state consultants visited Louisiana in March 2016 to interview campus representatives, evaluate the proposals, and rank them using the guidelines provided in the Board's RFP and subprogram policy. (See **Appendix A** for the rank-order list of FY 2015-16 Endowed Chairs proposals and **Appendix B** for a summary of all competitive endowment proposals recommended for funding.)

It should be noted that the following stipulation in the Board's Endowed Chairs policy is relevant to proposals submitted in the Competitive subprogram: "...When requests exceed funds available, the following limitations apply relative to the amount of money that will be awarded per campus under the competitive program: (a) each public campus will be limited to \$1.2 million per fiscal year; and (b) all LAICU campuses combined will be limited to a total of \$1.2 million per fiscal year."

The \$3,220,000 projected in the FY 2015-16 Plan and Budget to be available in the Endowed Chairs for Eminent Scholars subprogram includes \$20,000 for consultants. The remaining amount of \$3,200,000 will enable funding for proposals ranked 1-5 in the Competitive subprogram.

Senior Staff Recommendation

The Senior Staff recommends provision of Support Fund money at levels requested to complete the endowments for proposals ranked 1, 2, 3, 4, and 5 in the Consultants' Report (i.e., proposals 001EC, 006EC, 005EC, 003EC, and 007EC). (See Appendix A.)

SECTION C: ENHANCEMENT OF THE QUALITY OF DEPARTMENTS OR UNITS COMPONENT

C.1 Recommended New Traditional, Undergraduate and Two-Year Institutions Enhancement Projects

The \$11,151,770 figure cited in the FY 2015-16 Plan and Budget for Enhancement included the following distributions:

Note that the Supervised Undergraduate Research subprogram was eliminated and Endowed Two-Year Workforce Scholarships was reduced by \$640,000 to accommodate reductions to statutory dedications authorized during the 2016 Special Legislative Session.

The five eligible disciplines in the Traditional and Undergraduate Enhancement subprogram components in FY 2015-16 are agricultural sciences, arts, earth and environmental sciences, engineering A (chemical, civil, and electrical and electronics), and health and medical sciences.

In the winter of 2015 and spring of 2016, seven teams of out-of-state consultants reviewed, evaluated and ranked the various types of competitive Enhancement proposals. Using the Board’s evaluation criteria, five teams evaluated, rated and ranked Traditional Enhancement proposals in the five eligible disciplines; the sixth and seventh teams, respectively, evaluated, rated and ranked Multidisciplinary Enhancement and Undergraduate Enhancement. The Endowed Two-Year Workforce Scholarships subprogram received only \$460,000 in funding requests, so no review was conducted. Each team had appropriate expertise and experience relative to the specific requirements of the discipline and/or component being reviewed.

With the exception of the Multidisciplinary component, the allocation level for each of the eligible disciplines in the Traditional Enhancement subprogram was determined by calculating proposal pressure and the amount of Support Fund money requested per discipline as a percentage of the total proposal pressure and amount of Support Fund money requested across these five disciplines in the Traditional Enhancement component. As stipulated in the FY 2015-16 Plan and Budget, Multidisciplinary Enhancement was calculated as 20% of the total available. The total maximum funding anticipated to be available for meritorious proposals in each of the root disciplines in Traditional Enhancement as well as Multidisciplinary Enhancement, based on allocations in the FY 2015-16 Plan and Budget, was calculated as follows:

These amounts helped to guide consultants in the development of funding recommendations. Senior Staff Recommendations

- 1. Traditional Enhancement:** The \$3,174,584 available and recommended for expenditure shall be awarded in the rank order, at the funding levels, and with the funding stipulations recommended by consultants, and shall be divided among the five eligible disciplines and multidisciplinary projects as follows (see Appendix C):

- 2. Undergraduate Enhancement:** A total of \$1,352,428 is recommended for expenditure for the top twenty-one (21) Undergraduate Enhancement proposals submitted in FY 2015-16. Proposals shall be awarded in the rank order, at the funding levels, and with the funding stipulations recommended by consultants. (See Appendix D.)
- 3. Should the amount of money ultimately available to fund first-year activities in Traditional and Undergraduate Enhancement projects be less than the \$4,527,012 disbursed herein, the following principles shall apply:** (1) All Support Fund money shall be awarded in rank order, at funding levels and with stipulations recommended by consultants; (2) if the remaining money in the budget for a particular component or discipline is insufficient to fully fund the next recommended proposal for that component or discipline, the remaining funds shall constitute the total award for that proposal; and (3) should an institution refuse or be denied an award, that money shall be awarded to the next highest ranked proposal within that component or discipline. (See Appendices C and D.)

Appendix E summarizes – by campus and Enhancement component – the Priority I recommendations for new projects under the competitive Enhancement subprograms.

C.2 Endowed Professorships

The Board of Regents Support Fund Endowed Professorships subprogram requires the submitting college or university to raise at least \$60,000 from external sources, which is matched by \$40,000 from the Support Fund, thus establishing an endowed professorship valued at a minimum of \$100,000. The subprogram policy guarantees two \$40,000 matching slots to each four-year and special purpose campus, and one \$40,000 matching slot to each two-year campus.

The FY 2015-16 Support Fund Plan and Budget allocates a total of \$1,600,000 to the Endowed Professorships subprogram for new, prior-year (resubmitted), and backlogged requests. With all requests validated, the Board received by the March 31, 2016 deadline applications for 195 Endowed Professorship \$40,000 slots (101 new requests; 54 prior-year requests; 40 backlogged) from 20 campuses, requiring \$7,800,000 in BoRSF matching funds. One submission, from Southern University and A&M College, was deemed ineligible in accordance with the Board's January 2016 action relative to campus vacancy rates. Each eligible submitting campus will receive matching for a maximum of two slots (\$80,000), totaling \$1,360,000. The \$240,000 remaining, along with an additional \$40,000 transferred from the First-Generation Endowed Undergraduate Scholarships subprogram, will match seven backlogged slots at LSU and A&M College (See **Appendix F.**) A complete list of Endowed Professorships applications submitted for funding consideration in FY 2015-16 appears in **Appendix G.**

Senior Staff Recommendation

The Senior Staff recommends approval of \$1,600,000 from the Support Fund for the Endowed Professorships subprogram: \$1,360,000 to match thirty-four (34) new and prior-year and \$240,000 to match six (6) backlogged submissions. An additional \$40,000 shall be transferred from the First-Generation Endowed Undergraduate Scholarships to match one (1) additional backlogged request. (See Appendix F.)

C.3 First-Generation Endowed Undergraduate Scholarships

The Board of Regents Support Fund First-Generation Endowed Undergraduate Scholarships subprogram requires a submitting four-year college or university to raise at least \$60,000 from external or institutional sources, which is matched by \$40,000 from the Support Fund, thus establishing an endowed scholarship valued at a minimum of \$100,000; two-year campuses must provide \$30,000, to be matched with \$20,000 from the Support Fund to establish an endowed scholarship valued at a minimum of \$50,000.

The FY 2015-16 Support Fund Plan and Budget allocates a total of \$1,000,000 to the First-Generation Endowed Undergraduate Scholarships subprogram for the establishment of at least 25 endowed scholarships for first-generation undergraduate students. With all disciplines eligible and all requests validated, the Board has received applications for five (5) \$20,000 and twenty-seven (27) \$40,000 scholarship matches. It would require \$1,180,000 to fund all submissions. A list of applications appears in **Appendix H.**

Each submitting campus will receive a maximum of three matches for scholarship submissions, totaling \$940,000. After funding three submissions per eligible campus, remaining funds of \$60,000 are insufficient to provide a fourth match to all campuses with more than three requests; of this remainder, \$40,000 shall be transferred to the Endowed Professorships program to match one (1) backlogged request. (See Section C.2, above.)

Senior Staff Recommendation

The Senior Staff recommends approval of \$940,000 from the Support Fund to match twenty-six (26) applications submitted in FY 2015-16 under the First-Generation Endowed Undergraduate Scholarships subprogram. In addition, \$40,000 shall be transferred to Endowed Professorships to match one (1) additional backlogged slot. (See Appendix H.)

C.4 Endowed Two-Year Student Workforce Scholarships

The competitive Endowed Two-Year Student Workforce Scholarships subprogram provides scholarship opportunities for students on two-year campuses to enter the Louisiana workforce in the following ways: (a) train students for immediate entrance into selected, high-demand, four- and five-star jobs, including positions in nursing and allied health; and/or (b) prepare students to become job-ready in STEM fields after completing degrees on four-year campuses. Non-State contributions combined with a BoRSF match will produce permanent endowments. This subprogram replaces the Enhancement Subprogram for Two-Year Institutions.

The FY 2015-16 Support Fund Plan and Budget allocates a total of \$1,100,000 to the Two-Year Student Workforce Scholarships subprogram, to be awarded on a competitive basis. With all requests validated, however, the Board has received applications for the matching of 27 scholarships, requesting BoRSF funding of \$460,000. A list of applications appears in **Appendix I**. It was determined that a competitive review was not needed and all requests should be recommended for funding. (See **Appendix B** for a summary of all competitive endowment proposals recommended for funding.) The \$640,000 remaining in the subprogram budget was cut as part of the mandatory reduction approved by the Legislature and the Governor.

Senior Staff Recommendation

The Senior Staff recommends approval of \$460,000 from the Support Fund to match twenty-seven (27) applications submitted in FY 2015-16 under the Endowed Two-Year Workforce Scholarships subprogram. (See Appendix I.)

SECTION D: RESEARCH AND DEVELOPMENT COMPONENT

D.1 Continuation of Previously Funded Research and Development (R&D) Projects and Other Prior Commitments

The \$5,870,000 cited in the FY 2015-16 Plan and Budget as being available for Research and Development (R&D) includes amounts for prior commitments to Support Fund R&D awards approved in previous years as well as approximately \$135,000 in consultants' costs for the FY 2015-16 R&D review process.

D.2 Recommended New Research and Development Projects

The R&D component of the BoRSF includes the Research Competitiveness Subprogram (RCS) with Pilot Funding for New Research (Pfund) component, the Industrial Ties Research Subprogram (ITRS) with Proof-of-Concept/Prototyping (PoC/P) initiative, and the Awards to Louisiana Artists and Scholars (ATLAS) subprogram. RCS and Pfund solicit proposals that strengthen the research foundations and competitiveness of Louisiana colleges and universities and help to promote long-term economic development. ITRS and PoC/P target proposals that support research with significant near-term potential for development and diversification of Louisiana's economic base. ATLAS supports completion of major scholarly and artistic endeavors from the arts, humanities, and social sciences with potential for broad impact on State, regional, national and/or international levels.

Eligible disciplines in RCS/Pfund for FY 2015-16 are agricultural sciences, biological sciences, computer/information sciences, earth and environmental sciences, engineering A (chemical, civil, and electrical and electronics), mathematics, physics and astronomy, and social sciences. ITRS and PoC/P invite ideas across all disciplines for applied research projects that promoted near-term economic development in the State; therefore, no specific target areas or disciplines are defined. ATLAS accepts proposals in all arts, humanities and social sciences areas.

From November 2015 through March 2016, approximately 350 mail and subject-area reviewers and four final panels reviewed, evaluated, and ranked research proposals according to the Board's RFP guidelines and

evaluation criteria. The following table summarizes consultants' recommendations across the five R&D subprograms/components (See **Appendix J**):

Senior Staff Recommendations

The Senior Staff recommends approval of disbursement of \$2,739,234 estimated to be available in FY 2015-16 to fund the first year of new RCS, Pfund, ITRS, PoC/P, and ATLAS projects as follows:

1. Research Competitiveness Subprogram: \$1,199,662
2. Pilot Funding for New Research Component: \$330,400
3. Industrial Ties Research Subprogram: \$533,074
4. Proof-of-Concept/Prototyping Initiative: \$291,814
5. Awards to Louisiana Artists and Scholars: \$384,284

Approved R&D proposals shall be funded at the levels and with the stipulations recommended by consultants. Support Fund money shall be awarded to fund at recommended levels the top twenty-five (25) RCS proposals, seventeen (17) Pfund proposals, eight (8) ITRS proposals, eight (8) PoC/P proposals, and nine (9) ATLAS proposals. In addition, the following principles shall apply: (1) should an institution refuse or be denied an award, or should FY 2015-16 money be returned from previously funded R&D contracts, that money shall first be used to provide full funding to rank orders partially supported with remaining funds, then offered to the next-ranked proposal which the consultants recommended for Priority I funding within the respective subprogram (ranks 10-15 in ATLAS; ranks 26-28 in RCS; and rank 9 in ITRS), subject to availability of funds; (2) if the remaining money in the budget for a particular component is insufficient to fully fund the next-ranked recommended proposal for that component, the remaining funds shall constitute the total award for that proposal; and (3) if there are no remaining Priority I proposals in a particular subprogram the money shall be awarded in descending rank order to Priority I proposal(s) in another R&D subprogram in accordance with restrictions applicable to allocation of funds for multi-year projects. Should the amount of money ultimately available to fund first-year activities in all R&D projects be less than the \$2,739,234 disbursed herein, adherence to the following principles shall be uniformly enforced: R&D Priority I proposals shall be funded in rank order at the levels and the durations and with the stipulations recommended by consultants until the funds designated for each component have been exhausted. (See Appendix J.)

Appendix J also includes a summary, by campus and R&D subprogram, of new projects recommended for funding.

SECTION E: RECRUITMENT OF SUPERIOR GRADUATE STUDENTS COMPONENT

E.1 Traditional Graduate Fellowships

Awards must be made under the Recruitment of Superior Graduate Students Program component more than one year prior to the time that funds are provided for the first year of the fellowship, since at least one year is required to conduct student recruitment activities, and committed for all remaining years to ensure ongoing student support.

The twelve eligible disciplines in the Traditional Graduate Fellows component in FY 2015-16 are agricultural sciences, arts, biological sciences, chemistry, computer and information sciences, earth and environmental sciences, engineering A and B, health and medical sciences, humanities, mathematics, physics and astronomy, and social sciences.

In February 2016, a team of out-of-state consultants, with expertise in both doctoral and master’s-level programs, reviewed, rated and ranked thirty (30) Traditional Graduate Fellowships proposals in accordance with the Board’s evaluation criteria. A total of \$2,629,048 in first-year funds was requested for Traditional Graduate Fellowships, and consultants were informed that \$900,000 in first-year funds were allocated in the Plan and Budget for new projects. All funded projects will begin in FY 2017-18.

Of the proposals submitted, the consultants recommended the top-rated twenty (20) Traditional Graduate Fellowships applications, for a total first-year expenditure of \$835,000. (See **Appendix K.**) Yearly funding totals for all recommended proposals are:

Senior Staff Recommendation

The Senior Staff recommends approval of funding for the twenty (20) top-ranked Traditional Graduate Fellows proposals submitted in the FY 2015-16 cycle for the durations and at the levels recommended by consultants. (See Appendix K.)

E.2 BoRSF/Southern Regional Education Board Graduate Fellowships to Promote Diversity

Four (4) institutions submitted a total of four (4) proposals requesting funds for the support of 17 doctoral fellows in the FY 2015-16 competitive cycle for this subprogram. (See **Appendix K.**) A total of \$425,000 in first-year funds was requested. Consultants recommended support for all four (4) proposals, for a total first-year allocation of \$250,000. Funding will begin in FY 2016-17. For the recommended proposals, the yearly funding totals are:

Senior Staff Recommendation

The Senior Staff recommends approval of funding for the four (4) proposals submitted in the FY 2015-16 cycle to the BoR/SREB Graduate Fellowships to Promote Diversity subprogram for the durations and at the levels recommended by consultants. (See Appendix K.)

Appendix K also contains a summary of the recommendations of Traditional Graduate Fellowships and BoR/SREB Graduate Fellowships proposals solicited in FY 2015-16, for which funding will begin in FY 2017-18 and FY 2016-17, respectively.

E.3 Endowed Superior Graduate Student Scholarships

The Endowed Superior Graduate Student Scholarships subprogram matches non-State contributions of at least \$60,000 with \$40,000 from the BoRSF to create endowed scholarships that may be used in support of graduate and first-professional students as well as post-doctoral fellows. Higher levels of endowment, in minimum increments of \$60,000, may be matched with additional \$40,000 contributions from the Support Fund. The initial corpus of the endowment must remain intact, while income above the corpus may be used to benefit the student recipient in the form of scholarships, fellowships, and/or experiential opportunities, including internships, externships, conference travel, and field work.

The FY 2015-16 Support Fund Plan and Budget allocates a total of \$2,000,000 to the Endowed Superior Graduate Student Scholarships subprogram, to be awarded on a competitive basis. With all requests validated, however, the Board has received applications for the matching of 23 scholarships, requesting BoRSF funding of \$1,400,000. A list of applications appears in **Appendix L**. It was determined that a competitive review was not needed and all requests should be recommended for funding. (See **Appendix B** for a summary of all competitive endowment proposals recommended for funding.) The \$600,000 remaining in the subprogram budget was cut as part of the mandatory reduction approved by the Legislature and the Governor.

Senior Staff Recommendation

The Senior Staff recommends approval of \$1,400,000 from the Support Fund to match twenty-three (23) applications submitted in FY 2015-16 under the Endowed Superior Graduate Student Scholarships subprogram. (See Appendix L.)

SECTION F: CONTINGENCY PLAN FOR BUDGETARY SHORTFALL

Senior Staff Recommendation

The Senior Staff recommends approval of the following contingency plan for a budgetary shortfall: should the final FY 2015-16 Support Fund budget not achieve the amount cited herein, any shortfall shall be accommodated through a proportionate reduction in the amounts allocated for proposals in the competitive non-endowment Enhancement and Research and Development program components.

Campus Request for Waiver of Endowed Chair National Search Requirement: University of New Orleans

Background

At its January 12, 2015 meeting, the Board unanimously approved the following revision to the Endowed Chairs for Eminent Scholars policy:

Effective immediately, all campuses shall provide documentation to the Commissioner of Higher Education that each Chair vacancy is being filled – whether externally or internally – following a national search. Any request for waiver of this policy shall be made in writing to the Commissioner of Higher Education and reviewed by external consultants. Upon receipt of the consultants' response, the Commissioner will provide a formal recommendation for consideration and approval by the Board of Regents. Board approval of the waiver must be provided prior to appointment of the chairholder. The Board reserves the right to render a campus not in compliance with this policy to be ineligible for new Endowed Chairs funds.

In accordance with this policy, the University of New Orleans has submitted a request for a waiver of the Endowed Chair national search requirement, to appoint Dr. Enrique LaMotta to the Edward G. Schlieder Chair for Urban Environmental Waste.

Documentation outlining Dr. LaMotta's qualifications was provided to Dr. Roy Koenigsnecht, professor emeritus at the Ohio State University and chair of the BoRSF Endowed Chairs for Eminent Scholars review panel. Dr. Koenigsnecht concluded that this appointment is appropriate and recommended approval; Dr. Joseph C. Rallo, Commissioner of Higher Education, concurred.

Senior Staff Recommendation

The Senior Staff recommends approval of UNO's request to appoint Dr. Enrique LaMotta to the Edward G. Schlieder Chair for Urban Environmental Waste, with the stipulation that UNO will submit to the Commissioner of Higher Education by May 31, 2019 a report of Chair activities during the first three years of appointment. The report will reference the standards of performance listed in the Endowed Chairs policy and UNO's letter of appointment to Dr. LaMotta.
